

## **UPDATE: SEA OTTER TRANSLOCATION**

U.S. Fish and Wildlife Service announced southern sea otters will continue as a threatened species under the *Endangered Species Act*. Following an in-depth review of the species' status, including information provided by species experts, the Service has announced a not-warranted 12-month finding on a petition to remove ESA protection for the southern sea otter.

In 2021, directed by Congress, the Service assessed the feasibility of reintroducing sea otters to portions of the coast in Northern California and Oregon where they once thrived. The assessment concluded reintroduction was biologically feasible and <a href="mailto:may">may</a> have significant benefits for sea otters and nearshore marine ecosystems. But, additional information about how reintroduction would affect stakeholders and local communities is needed before considering next steps. There is no active proposal to reintroduce sea otters at this time.

<u>Climate Change Is Creating Bigger Waves on California Coasts Nathan Rott</u> KQED 9/1, 2023 Earlier this year, California was pummeled: massive waves damaged piers, crumbled sea cliffs and flooded coastlines. A new study finds wave heights are getting bigger along the California coast as global temperatures have warmed. Global climate-warming carbon dioxide has increased by about 90% since 1970.

The study, published Tuesday in the *Journal of Geophysical Research: Oceans*, looked at nearly a century's worth of data, and found that the average height of winter waves have grown by about a foot since 1969. The number of storm events producing waves greater than 13 feet in height has also increased.

Bigger waves can be damaging to California's already climate-vulnerable coast. Warmer ocean temperatures and inflows of freshwater from the world's melting ice caps have caused sea levels to roughly 8" along California's 1,200 mile coastline in the last century.

#### Invasive New Zealand Mudsnails Discovered in Lake Tahoe

The California Department of Fish and Wildlife (CDFW) was informed by the Tahoe Regional Planning Agency (TRPA) that divers monitoring for aquatic invasive species in Lake Tahoe detected invasive New Zealand mudsnails (Potamopyrgus antipodarum) in areas off the South Shore of Lake Tahoe. New Zealand mudsnail samples were subsequently positively identified by experts within CDFW and an outside genetics lab. This is the first time the species has been detected in Lake Tahoe.

<u>New Zealand mudsnails (NZMS)</u> are tiny, aquatic snails reaching up to 4-6 millimeters long. Despite their small size, NZMS are a highly problematic aquatic species. Dense populations can displace and outcompete native species, sometimes by consuming up to half the food resources in the waterway.

CDFW urges anglers, boaters, visitors and locals to "clean, drain and dry" all recreational items and fishing gear, meaning anything that has gotten wet. Once NZMS are established in a new habitat, they are impossible

to eradicate without damaging other components of the ecosystem. Boaters, anglers and others who may visit any body of water, within or outside of infested areas, are asked to decontaminate their equipment and follow the "clean, drain and dry" best practices for all equipment and clothing used in a waterway.

# \$2 MILLIONS ALLOCATED TO RENOVATE NATIONAL MARINE SANCTUARIES GREATER FARALLONES AND CORDELL BANK

NOAA is investing \$2 million the Greater Farallones and Cordell Bank National Marine Sanctuaries to support critical repairs and updates to a facility on the Sanctuary's campus in San Francisco. NOAA will renovate a historic former lifeboat station garage, converting it into an ocean learning center for hands on education and outreach on marine conservation. Located on the promenade of the Golden Gate National Recreation Area's Crissy Field, the area attracts more than a million visitors and locals a year. The renovated facility expands the sanctuary's ability to service students and communities through educational programming.
